The continued growth in legalization of medical cannabis and recreational marijuana around the U.S. creates some unique challenges to employers. U.S Attorney General Jeff Sessions created a buzz by saying that the federal government should enforce the laws that make marijuana illegal and OSHA believes that blanket post-accident testing is inappropriate. So the question isn't whether the workforce is impaired (by marijuana, opioid, alcohol or illicit drug) but how to manage it. How can an employer best foster a safe workplace while still having enough employees to get the job done? The subject of marijuana is driving a lot of these questions and there do not appear to be any simple answers. But Mark will try!
